Sir,

I am directed to say that Government of Assam in the Education (Higher) Department is pleased to convey the Part-II concurrence for obtaining the permission/affiliation to start the subjects as detailed against the college mentioned below subject to the fulfillment of all the required conditions laid down by concerned University (s) and UGC Guidelines thereon.

The grant of said concurrence for obtaining permission/affiliation as detailed below is governed by the following terms and conditions:

- (1) Government will not incur any financial burden /liability for increase on the teaching staff/accommodation of the concerned college for the aforesaid TDC Part-II concurrence.
- (2) UGC norms and Guidelines like acquiring of NET/SLET/M. Phil and Ph. D qualification are made essential/mandatory requirement for college teachers.
- (3) The Principal must acquire Ph. D including minimum requirement of UGC norms to be eligible for holding the post of Principal.

However, to acquire the mandatory qualification, the faculty members including Librarians who could not acquire it all of them must acquire it within 5 (five) years time frame from the date of issue of the concurrence order, otherwise the college authority must remove them from service who fail to achieve it within the time frame specified above. The existing Principal of the college will have to acquire Ph. D Degree to be eligible for the post of Principal as per the time frame mentioned above.

On receipt of concurrence order, the College Authority should issue an order to each faculty member not having full UGC norms to acquire the same within the time frame failing which their services stand terminated. A copy of the order issued should be marked to Director of Higher Education and Education (Higher) Department.
